Payment Terms

A non-refundable deposit of **20%** of the total service cost is required to secure the booking. **This deposit will be applied toward your final bill.** The remaining balance is due on or before the wedding date.

A **\$50 travel fee** will also be applied to the final bill.

Acceptable payment methods: Venmo, cash, or credit card. Any additional services requested on the day of the event will be charged accordingly and are due at the time of service.

Cancellation Policy

If the Client cancels within **14 days** of the wedding date, full payment of the remaining balance is required. The 20% deposit is non-refundable in all cases. In the rare event Enchanted Hairstyles cannot provide service due to emergency or illness, all payments including the deposit will be refunded, or an alternative stylist will be arranged if possible.

Scheduling and Timing

The Client agrees to adhere to the agreed start time to ensure all services are completed as scheduled. Delays from the Client or bridal party may impact the schedule and the final results.

Health and Safety

The Client must inform Enchanted Hairstyles of any allergies, sensitivities, or medical conditions pertinent to hair styling.

Client Acknowledgment

By signing, you confirm that you agree to these terms and that all details are accurate.

Photography and Marketing Consent

By signing this agreement, the Client grants Enchanted Hairstyles permission to take photographs of the hairstyling results and use these images for marketing purposes, including but not limited to social media, website content, and promotional materials. If the Client prefers not to grant this permission, they may opt out by providing written notice to Enchanted Hairstyles at the time of signing or before the wedding date.
